### **Rules of Play for GHF Raffle:**

The lottery for the Georgetown Hospital Foundation (GHF) Raffle will take place starting February 3, 2025 with ticket sales continuing to March 25, 2025. Ticket sales will close at 11:59 p.m. EST on March 25, 2025. The final draw for the grand prize and consolation prizes will be held on March 26, 2025 at 9:00 a.m. at Georgetown Hospital.

1. Early bird draws will be held on:
  - February 19, 2025 at 9:00 a.m. at Georgetown Hospital. All tickets purchased prior to this date and time will be included in the early bird draw.
  - March 12, 2025 at 9:00 a.m. at Georgetown Hospital. All tickets purchased prior to this date and time will be included in the early bird draw.
2. All tickets will only be sold to people who are 18 years of age or older.
3. Tickets are 1 for \$10.00, 3 for \$20.00 and 8 for \$40.00. A maximum number of 9,993 tickets will be sold.
4. Tickets will be sold online at [ghf.rafflenexus.com](https://ghf.rafflenexus.com).
5. Tickets will be sold using an electronic raffle system supplied by Raffle Nexus Canada Inc.
6. Tickets will be drawn from fourth prize to first prize.
  - First prize: Expedia Cruises 7 night Caribbean Cruise with Norwegian Cruise Lines on board the Norwegian Encore for two including round trip air fare (value \$7,132.18)
    - i. Fare includes: flight departing from Toronto Pearson Airport to Miami International Airport, return flight from Miami International Airport to Toronto Pearson, More at Sea beverage package, More at Sea specialty dining package, 150 minutes More at Sea Wi-Fi and pre paid gratuities.

7. Early bird prizes will be a \$1000.00 cash prize each.
  8. Total prize board of \$9,992.15.
  9. After buying, patrons will receive a confirmation email with their registered raffle numbers from a Random Selection System. No specific numbers can be given as numbers are generated randomly.
  10. The winning ticket number will be selected by a Random Number Generation (RNG) system from all raffle numbers sold for the draw. After each winning ticket is drawn it will be returned and eligible for all subsequent draws.
  11. The winning number will be announced on the Georgetown Hospital Foundation website on the date of the draw. All winners will be notified by mail, email or phone. Winners agree to the use of their first name and photo for announcement/publicity purposes by Georgetown Hospital Foundation.

  13. The ticket may then be brought to 1 Princess Anne Drive, Georgetown, ON L6G 2B8 at an agreed upon time for ticket verification. The winner will then be presented the prize as indicated.
  14. It shall be the responsibility of the cruise winner to cover the costs of transportation (to Toronto Pearson Airport for departure flight, transportation to cruise dock from Miami International Airport upon arrival, transportation from cruise dock to Miami International Airport for return flight, transportation from Toronto Pearson Airport to residence) travel insurance, and pre and post cruise accommodations if required. Additional costs include specialty restaurants onboard, personal purchases in destination, excursions and premium level beverages.
  15. Once the certified winner is verified, and provides identification with photo ID, they will be given the prize. If the winner cannot provide photo ID, then the winning proceeds will be held until such identification can be provided.
